He says widow has been ill a long time and is incapable of managing affairs. That she is bedridden.

Pio Linares says his sister Eudrofila Linares, youngest child of Victor Linares, is a minor about 13 years of age. Asks Court to appoint a guardian inasmuch as she [Eudrofila] is now living with her mother who is sick and infirm and incapable, etc, and that the child's education is being utterly neglected.

Widow says Victor Linares died in the Count on or about 5 June 1853.
